



International Student Award (ISA)

Scholarship details

15% contribution towards the tuition fees each term for the duration of program.

Eligibility

To be eligible, applicants must meet all of the following criteria:

- Be an International Student; and
- Be a citizen of an eligible country; and
- Must not be a current student of UNSW College

ISA is open to students commencing their studies at UNSW College in 2025 or 2026.

Application process

To apply for the UNSW International Student Award applicants must submit a personal statement of no more than 500 words outlining their reasons to study the proposed program at UNSW.

New applicants can upload their personal statement through **Apply Online** as part of their application.

Terms and Conditions

The UNSW College International Student Award is available to eligible students from lower income and developing countries (Refer to Table A). The Award is open to all commencing students with defined citizenships enrolled full time in UNSW College Diploma or Pre-Masters Program.

1. Eligibility

- a. To be eligible for the Award, applicants must be an international student as defined in the UNSW College Admissions Policy.
- b. Applicants must hold citizenship of a country listed in Table A. Proof of citizenship will be required.
- c. Applicants must have an offer of admission for UNSW College Diploma or Pre-Masters Program to be offered the Award.
- d. The Award is only applicable to Diploma program where tuition fees are payable to UNSW College.
- e. The Award is applicable to new students commencing in an eligible term where the Award is offered. Students who have completed a Foundation program at UNSW College and are commencing a Diploma program will be considered a new student for the purposes of the Award.
- f. The Award is not applicable to students studying any program offered by UNSW. For details about UNSW International Student Award, please refer to https://www.scholarships.unsw.edu.au/international-student-award

2. **Selection Criteria:** To be successful in obtaining the Award, applicants will need to meet the entry criteria for admission to the program at UNSW College.

3. Value

- a. Award recipients will receive a 15 percent contribution to their tuition fee from UNSW College for the duration of their Diploma or Pre-Masters program.
- b. No payment will be made directly to the student, the Award will be applied to the applicant's record which will reduce the applicant's overall tuition fee liability.
- c. No other amount is payable.

4. Ongoing eligibility

To continue receipt of the Award, the recipient must:

- a. have no outstanding fees
- b. maintain full time enrolment
- c. be enrolled in UNSW College Diploma or Pre-Masters program

5. **Termination**:

The Award will be terminated if the recipient:

- a. graduates from an eligible program
- b. withdraws from an eligible program or fails to enrol
- c. becomes a domestic student as defined in the UNSW College Admissions Policy
- d. fails to complete their program in the given timeframe indicated in their Certificate of Enrolment (CoE)
- e. is determined by UNSW College to be guilty of serious misconduct, including, but not limited to, having provided false or misleading information as part of their application; or
- f. any other provision as indicated in these terms that would lead to termination.
