How to Apply	Offer holders commencing either UNSW College Foundation Studies or
	Diploma programs at our Sydney campus who have a relative who has
	graduated from UNSW College, or a relative who is currently enrolled in
	one of our Foundation Studies or Diploma programs, may apply for the
	UNSW College Family discount.
	Applicants will be required to provide evidence of their legitimate family
	relationship which may include:
	The relative's full name (s)
	 The relative's date of birth (for identification purposes)
	The relative's student ID
	The relative's certificate of graduation from their UNSW College
	program of study
	 Evidence of the relationship between the new student and the relative
	Cousins or siblings who are enrolled at a UNSW College Foundation
	Studies or Diploma program concurrently may be eligible to apply.
	Any family discount will only be awarded or applied to the second or

Terms and	UNSW College Family Discount – Terms and Conditions
Conditions	1. Background
	To qualify for the Family Discount, eligible applicants must be:
	Enrolled in a UNSW College Foundation Studies or Diploma program,
	and have an eligible relative (parents, uncle/aunt, sibling, cousin) who is
	either:
	 A graduate of UNSW Foundation Studies, or A graduate of UNSW College Foundation Studies, or
	A graduate of Onow College Fourtuation Studies, of

- A graduate of UNSW Diploma, or
- A graduate of UNSW College Diploma, or
- A sibling currently enrolled in a UNSW College Foundation Studies or Diploma program.

2. Eligibility

- a) The Family Discount is available to both international and domestic students.
- b) Eligible relatives include parents, siblings, cousins, aunts, and uncles who:
 - Successfully graduated from UNSW Foundation Studies or UNSW College Diploma programs; or
 - Are siblings currently enrolled in a UNSW College Foundation Studies or Diploma program (discount applies to second and subsequent enrolments only).
- c) Applicants must provide:
 - A graduation certificate from UNSW College, UNSW Foundation Studies, UNSW Global, or UNSW Institute of Languages; and
 - Evidence of the familial relationship to the applicant.
- d) The discount applies only to new enrolments in 2026 for Foundation Studies or Diploma programs.
- e) The discount does not apply to:
 - Diploma of Business; or
 - · Foundation Studies Commerce stream; or
 - Foundation Studies Commerce Actuarial Studies stream.
- f) Sponsored students are not eligible.
- g) The Family Discount cannot be combined with the UNSW International Student Award. It may be combined with the UNSW College Regional Merit Scholarship.
- h) Deferral of the Family Discount is permitted.
- i) The Family Discount is awarded at the sole discretion of UNSW College.

3. Application Process

- a) Applicants must submit the following documentation:
 - Full name, date of birth, and student ID of the relative;
 - Proof of relationship (e.g., birth certificate, official family certificate, official family registration);
 - Graduation certificate showing graduation from the eligible program.
- b) For siblings concurrently enrolled, the discount applies to the second and subsequent enrolments only.
- c) Applications must be submitted to
- scholarships@unswcollege.edu.au at the time of accepting the offer.
- d) UNSW College reserves the right to verify all submitted information to determine eligibility.

4. Value and Duration



- a) Award recipients will receive a 10% tuition fee discount from UNSW College for the duration of their enrolment in a Foundation Studies or Diploma program.
- b) The maximum discount available under the UNSW College Family Discount is 10%, regardless of the number of relatives.
- c) The family discount will be applied to the student's invoice and reflected in their account after full tuition payment and once the census date has passed.
- d) No payment will be made directly to the student; the family discount will be applied to the recipient's record which will reduce their overall tuition fee liability.
- e) No additional amounts will be paid.
- f) The family discount is non-transferable and cannot be redeemed for cash.

5. Ongoing Eligibility

To maintain the Family Discount, recipients must:

- Have no outstanding tuition fees;
- Remain enrolled full-time in an eligible UNSW College Foundation Studies or Diploma program;
- Maintain satisfactory academic progress as defined by UNSW College policies.
- b) The Discount is valid only for students commencing in 2026.
- c) Recipients who withdraw or transfer to an ineligible program will forfeit the discount.
- d) The Family Discount will only apply to the standard duration of the student's Foundation Studies or Diploma program. Students who extend their studies beyond this due to change of mind, repeating or for any other reason will not be entitled to receive the Family Discount for the extended portion of the program.

6. Termination

The Family Discount will be terminated if the recipient:

- a) Graduates from the eligible program;
- b) Withdraws from the eligible program;
- c) Fails to complete the program within the timeframe specified in their Confirmation of Enrolment (CoE) or the maximum permitted time for domestic students;
- d) Is found to have committed serious misconduct, including providing false or misleading information in their application.
